## CHAPTER V

### CONCLUSION AND SUGGESTION

#### A. Conclusion

This research objective was to investigate if there is a significant correlation between students' summary writing ability and their reading comprehension of analytical exposition text at the eleventh grade of Islamic Senior High School Darul Hikmah Pekanbaru. Based on the analysis of the data in the previous chapter, the researcher points out some conclusion as follows:

1. The mean score of students' summary writing ability at the eleventh grade of Islamic Senior High School Darul Hikmah Pekanbaru is 71.00. the score is categorized into good level.
2. The mean score of students' reading comprehension of analytical exposition text at the eleventh grade of Islamic Senior High School Darul Hikmah Pekanbaru is 68.23. The score is categorized into good level.
3. There is a considerable evidence that summary writing both encourages and measures reading comprehension of analytical exposition text at the eleventh grade of Islamic Senior High School Darul Hikmah Pekanbaru. This has been proved by the value of correlation between students' summary writing ability and their reading comprehension of

  - a. The students should improve their summary writing ability to help them in comprehending and expressing their ideas through writing.
  - b. The students should build a good reading ability in their daily life and maintain it by continual reading activity so that they can improve their reading comprehension skill.
3. For the future researcher
  - a. The future researchers are expected to conduct researches about summary writing ability and reading comprehension by using a larger group of students or sample in order to get maximal results.
