CHAPTER V

CONCLUSION AND SUGGESTION

A. Research Conclusion

Based on the explanation in the chapter IV, finally the research about the comparison of students' English learning achievement who taught by using Powerpoint and whiteboard at plus senior high school of Riau province to the conclusions as follows:

1. The result of this research obtained that the English learning achievement of students who were taught by using Powerpoint at tenth grade of plus senior high school of Riau province on academic year 2017/2018 can be categorized "very good". it is shown by mean score of English learning achievement is 89.20
2. The result of this research obtained that the English learning achievement of students who were taught by using whiteboard at tenth grade of plus senior high school of Riau province on academic year 2017/2018 can be categorized "very good" It is shown by mean score of English learning achievement is 88.68
3. Based on table IV.14 the Sig. 2-tailed ($0.286 \geq 0.05$) because the probability (0.286) is higher than 0.05 its means the values prove that there is no significant difference in English learning achievement between students who were taught by using Powerpoint and those who were taught by using Whiteboard at tenth grade of plus senior high school of Riau province.

4. It is shown that the using of Powerpoint and Whiteboard as English learning media equally contribute on improving of students English learning achievement and both able to use in English teaching and learning process.

B. Suggestion

Considering the comparison of students' English learning achievement between students were taught by using Powerpoint and whiteboard at plus senior high school of Riau province, the writer would like to give some suggestion as follows:

1. Suggestions for the teacher:

- a. The result of this research was indicated that the teacher should to combine the use of Powerpoint and whiteboard in teaching and English learning process. the teachers suggest to not only focus on one learning strategy and media to make innovation and variant in learning and teaching process in order that the students can accept the lesson did not feel bored easily.
- b. The building up of creative and enjoyable learning for students should be developed by the teacher by applying the appropriate media in teaching and learning process such as combining both of Powerpoint and whiteboard.
- c. The teacher should improve the skill in improving the use of Powerpoint media, like the use of laptop and projector.
