CHAPTER I

INTRODUCTION

Background of the Problem

English is included in the national curriculum in every school in Indonesia. In mastering four skills in English, the students have to master vocabulary. So, vocabulary is the basic in learning English as the foreign language. In order to support the mastery of English skills, it is essential to learn vocabulary. It becomes a central part in English learning. Vocabulary refers to a list or set of words for a particular language or a list or set of words that individual speaker of a language might use (Hatch and Brown, 1995: 1).

According to Patty et al (1967:7) vocabulary is usually "all the words of a language" or "all of those words used by a particular person, groups of person, etc"or, often, "a list of words usually arranged alphabetically and defined".

The report of the National Reading Panel (2000:1) in Pikulski and Templeton, for example, concluded, "The Importance of vocabulary knowledge has long been recognized in te development of reading skills. As early as 1924, researcher noted that growth in reading poer relies on continous growth in word knowledge". Biemiller (2003:6), in DCFS, also stated that Vocabulary is a strong indicator of reading success.

SMP N 1 Singingi, Regency of Kuantan Singingi is one of the schools in Kuantan Singingi. The students also have difficulties in learning English

because the problem is the students have lack of vocabulary. When the students experience unadequate vocabulary mastery, they will have difficulties to understand the language. Since the vocabulary is the basic in learning another language, that's way the vocabulary is the crucial thing.

Researcher also found that the students felt difficulties in learning vocabulary. In the learning process, they just talked with their friends and were not interested in the learning process. Sometimes, when they feel bored they will go out for many times. When the teacher asked the students to make a sentence with their own words, just some of them could make it and the rest just did cheating.

The next problem is that this problem may be caused by the impletation of uninteresting teaching technique. Consequently, the teacher should change an other technique as a possible solution for the students to enrich their vocabulary.

Based on the researcher's preliminary observation at State Junior High School 1 Singingi Regency of Kuantan Singingi, many students experienced unadequate vocabulary mastery, they did not know the meaning of the vocabulary, the synonym and antonym. The researcher found some sympstoms as follow:

- Some of the students were not able to know the meaning of the vocabulary.
- 2. Some of the students did not know how to differentiate between synonym and antonym of English vocabulary.

Delimitation of the Problem

1. Effect

According to Oxford Dictionary (2010:138), effect is a change which is a result or consequence of an action or other, effect is defined as the result of teaching vocabulary by using Four Corners strategy.

2. Strategy

3. Four Corners

This strategy helps the students to think at a higher level, reflect on what they have learnt in the class, voice out opinions safely, learn to critique on various issues, evaluate certain solutions and communicate better. Vocabulary refers to a list or set of words for particular language or a list of words that individual speakers of language use. Behlol (2010:78) in Macrothink Institute stated that vocabularies can be divided into passive vocabularies and active vocabularies. According to oxford Dictionary in fouth edition (2008:271), mastery is great skill of knowledge. Vocabulary knowledge means effectively able to recognize and use a word in different contexts, speak, write, and pronounce the word well and also precise comprehension which is operationalized as the ability to translate the lexical items into L1, the ability to find the right definition in a multiple-choice task, or the ability to give a target language paraphrase (Henriksen, 1996:11). Grabe (2009:79) in Macrothink Institute reported in his research that a new issue of current review about vocabulary mastery stressing on the importance of (a) making students aware of use the new words they encounter and (b) motivating the students to learn and use the new words, more ever the students need to be collectors of words either by listing words which are interesting or difficult, or by noting possible connection between new words and known words or trying to use the new words in some interesting way. On this vocabulary mastery, researcher only focused on students' ability to choose the correct answer in multiple choice.
