- A review section is completely missing in the paper. We think it is necessary to depict the state of the art, to introduce the scientific context of the paper and the aim of your proposal.

- References about negative and positive effects of cutting could support the statements of paragraph II.
- The conclusion is extremely weak. In the Conclusions, the authors should state the scope and the aims of this investigation, along with important research directions on this issue.

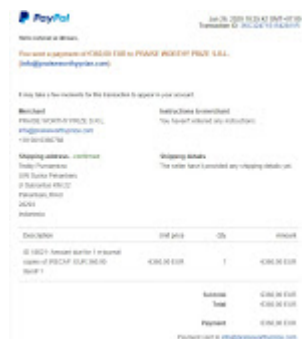

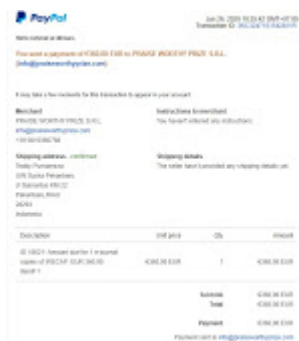
