Review summary:

This paper described an interesting design of a dual beam antenna system. The work is not quite complete for understanding. Some revisions are necessary.

- 1). The dual beam angles are 30 and 150 degrees. We would need to see the reasoning that you obtain these two angles (how the beam angles are related to the antenna structures and slot array arrangement).
- 2). Based on (1), how does one design such a array with a bema angle of other angles (20 or 40 or 60)? What is the limitation.
- 3). It looks like the array has large cross polarization. This issue is not addressed.
