1. Please clarify the statistical analysis, for figure 5

From your experimental design, it is evident that you have used three treatment groups, positive control, hydrolysate (two different doses), you have also mentioned that you have used t-test and compare it with the positive control group. according to figure 5 at 24 hr time point, 0.01g/kg BW treatment group exhibited a little less reduction of BP than 0.1g/kg BW group, then how is it possible to achieve \*\* ( $p < 0.01$ ) for 0.01g/kgBW treatment group? Similarly at 2 hr time point there is practically no difference between two treatment groups, then how these groups have different statistical significance?

2. Authors should justify the use of t-test over ANOVA for the animal experiments. As the BP and time, two factors are present in that particular analysis.
